**Minutes of August Meeting:** Hearing no objections or corrections to the minutes, Scott Perry moved and Jim Gandy seconded a motion and minutes approved unanimously.

**Treasurer's Report:** Doug Driver was not in attendance but had forwarded an update report to Patty which she passed out for review. After discussion, Charles Marshall moved, Matt Roy seconded and approved unanimously.

**Solo Update:** John Evans reported that Doug Driver & Jim Uchytel are co-chairs. Doug has been called out of town but Jim has the event under control. The course will be similar to the one used last year. Jim will be at Derby Field, Lovelock Friday afternoon and could use help in setting up. Jim Gandy reminded John that they had looked at Reno-Fernley to do a Solo event in conjunction with a Time Trials event using a portion of the top course. This will be taken into consideration for a 2007 event.

The October event at Stead Airport was to be chaired by Tyson Kueper and Dean Benz. However, Dean announced that he will be moving to Las Vegas for his job, in October. Pat Riley volunteered to co chair the event with Tyson.
