Financial Report

- Monthly reports
- Reimbursements/Expenditures
 - Pending – Web hosting to Cameron - \$53, one year
 - Solo Van registration renewal - \$83
- Still waiting on invoices from RPSTC for April thru July 2026
 - Received invoices for TRSS May 2026, and Solo June 2026. Checks written.
- Track – Thunderhill confirmed via email the remaining deposit on file is already applied to September 2026 event. Amount includes unused deposit carryforward from September 2025.

Regional Business

- May need a third driver for Solo van just in case.
 - No new volunteers so far...
- Fallon “Top Gun” Drag Strip
 - VP of site contacted with interest of adding to drag strip site to become multi-use Motorplex.
 - Visited July 17-18 Solo event.
 - No immediate short-term commitments. Long-term planning for now.

Street Survival

- Next event date – November 21
 - Registration for students open on MSR. Need to set up page for volunteers.
 - Due to skidpad used until 7pm previous day, setup will be at 7:30AM day of event.
 - Panos – How to advertise to raise awareness to teen students?

Solo

- July 18-19 – Rounds 7-8 Recap
 - Mostly smooth event. Hot weather. Saturday had timing start light issues during final runs on second run group.
- August 15-16 – Rounds 9-10 Recap
 - Smooth event. Very warm to mildly hot temperatures. No problems reported.

Time Trials and Track Events

- TA/TD #3-4 – Thunderhill 2-Mile West Course
 - Sanction approved. Insurance has been issued.
 - MSR has been updated, filled, and open for registration

- Ready for marketing.
- If we do not need to hire additional workers, we may breakeven on event.
- Only ~20 drivers so far. Another 20 would be great.
- Flagger volunteers needed (we can train).
- SFR RE asked if Reno SCCA interested in participating in season finale event.
 - October 16-18.
 - Reno SCCA unable to participate this year due to local Solo event on same weekend.
- Selling tow truck – Minimum \$5000.
 - Possible interest from Laguna Seca.
 - Dave spoke with potential buyer. Have not agreed on price yet. Open for negotiation.
 - No feedback heard since last month from interested party...
- 2027 Schedule Planning
 - No dates submitted yet.
 - Work with SFR to participate in Road Race events (like in March 2026)?
 - Likely difficult to get six hours in one day to prevent split event into two-days
 - First event – two groups buying time
 - At Sonoma a couple times, but not selling time due to high entry count.
